“NIEUW STATENDAM SETS SAIL SWEEPSTAKES”**

**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, CANADA (EXCLUDING QUEBEC), THE UNITED KINGDOM AND THE NETHERLANDS, AGE 18 OR OLDER. VOID WHERE PROHIBITED. - 1. ELIGIBILITY:** The Nieuw Statendam Sets Sail Sweepstakes (“Sweepstakes”) is open only to legal residents of the fifty United States, the District of Columbia, Canada (excluding Quebec), the United Kingdom and the Netherlands who have reached 18 years of age or older as of the date of entry. Employees of Sponsor, its subsidiaries, affiliates, distributors and advertising and promotion agencies, and such employees' immediate family and household members (whether related or not), are not eligible. The Sweepstakes is not open to residents in Quebec, U.S. territories or Dutch territories outside the Netherlands or where prohibited by law. The Sponsor reserves the right to verify eligibility qualifications of winner. The Sponsor’s decision is final in deciding the identity and/or eligibility of an entrant.
- 2. HOW TO ENTER:** The entry period for the Sweepstakes, sponsored by Holland America Line N.V. (“Sponsor”), begins at 12:00 A.M. Pacific Time (PT) on April 18, 2018 and ends at 11:59 P.M. PT on June 15, 2018 (the “Entry Period”). Entrants may choose to enter online or via postal mail.

2. Provide all requested information where indicated on any Nieuw Statendam Sets Sail Sweepstakes online advertisement on which an entry form appears and submit an entry.

Entrants entering the Sweepstakes by way of online entry will be required to submit his or her **first and last name, telephone number, e-mail address and such other information as Sponsor may require.**

Upon completion of the online entry page, entrants may opt to follow the on-screen instructions to share the Sweepstakes link via Twitter or Facebook in order to receive one additional entry.

To enter by mail, available only to residents of the U.S, Canada and the United Kingdom, during the Entry Period, eligible entrants may:

Entrants entering by mail-in method may opt to submit by mail one additional mail entry clearly marked with the words "Bonus Entry."

Online entries must be submitted during the Entry Period and received by Sponsor by 11:59 P.M. PT on June 15, 2018. Mailed entries must be postmarked during the Entry Period, no later than 11:59 P.M. PT on June 15, 2018, and received by 5:00 P.M. PT on June 22, 2018. Normal time rates, if any, charged by Internet service provider will apply. Proof of submission does not constitute proof of entry. Entry times will be determined using Sponsor's computer, which will be the official clock for the Sweepstakes. There is a limit of one Sweepstakes entry per person and per e-mail address and a limit of one bonus Sweepstakes entry per person and per e-mail address, regardless of method of entry. Additional entries from any one person or valid e-mail address in excess of the stated limitation will be void. In the event of a dispute regarding any entry, the entry will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry (i.e., the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address). 3. **WINNER SELECTION:** One potential Grand Prize winner will be selected in a random drawing conducted by an independent party on June 30, 2018 at 450 Third Avenue West, Seattle, WA 98119 from among all eligible entries received. Odds of winning depend on the number of eligible entries received. The potential winner is subject to verification, including verification of age. The potential winner will be notified by email, mail or phone, in Sponsor's discretion. The potential winner will be required to complete, sign and return to Sponsor, within ten days of the date notice or attempted notice is sent, an Affidavit/Declaration of Eligibility and Liability Release and, if legally permissible, a Publicity Release (collectively, a "Declaration and Release" for residents of Canada), and all information required for tax reporting, as applicable, per Section 4 herein in order to claim his/her prize or prize may be forfeited. The Grand Prize consists of one (1) seven- (7-)day Holland America Line Caribbean or Europe Cruise on the ms Nieuw Statendam for the winner and one (1) guest, sharing accommodations of one (1) verandah stateroom, departing in 2019, subject to availability at time of confirmation. The winner and guest must travel on the same itinerary. The prize consists of verandah stateroom accommodations for the winner and one (1) guest (same stateroom) and most shipboard meals (certain alternate dining options require payment of a fee). The approximate retail value (“ARV”) of the Grand Prize is: Caribbean cruise - \$2,278 USD / \$2,951 CAD / £1,631 GBP / € 1,838 EUR; Europe Cruise - \$3,998 USD / \$5,126 CAD / £2,880 GBP / € 3,244 EUR.
