## Argentina

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is not required and there is no entry fee required.
- Passports must be valid on arrival.
- Nationals from countries not listed above should verify their requirements with their local consulates or visa service provider.

## Aruba

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is not required when in transit with a cruise ship.
  - Guests participating in an Overland Adventure or Overnight tour during the cruise and will be entering the country by land or air during the tour, visa requirements may differ from the requirements of the cruise.
- Passports and other documents accepted for entry must be valid for the period of intended stay.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Australia

- Nationals of Austria, Canada, Germany, the Netherlands, Switzerland, the USA and the UK:
  - Electronic Travel Authorization (ETA) is required.
  - The ETA must be obtained prior to sailing.
  - Guests must show proof of confirmation at cruise check-in.

- Nationals of Australia and New Zealand:
  - ETA or visa is not required.
- Nationals of Brazil, Mexico and Romania:
  - Traditional visa is required.

- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Bahamas

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is not required when in transit with a cruise ship.
  - Guests participating in an Overland Adventure or Overnight tour during the cruise and will be entering the country by land or air during the tour, visa requirements may differ from the requirements of the cruise.
- Passports and other documents accepted for entry must be valid for the period of intended stay
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Barbados

- Visa is not required.

## British Virgin Islands

  - Visa is not required.

- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Cambodia

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is required for entry.
  - May be obtained onboard if arriving with the ship.
  - Visa and service fees may apply.
  - Guests participating in an Overland Adventure or Overnight tour during the cruise and will be entering the country by land or air during the tour, visa requirements may differ from the requirements of the cruise.
- Passports must be valid for a minimum of six months from the arrival date.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Canada

- Nationals of the USA:
  - Visa is not required.
  - If you are arriving to Canada by air, you may require an Electronic Travel Authority (eTA) even if you do not require a Temporary Resident Visa (TRV).

- Nationals of Canada:
  - Visa is not required.
- Nationals of Australia, Austria, Brazil, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland and the UK:
  - A Temporary Resident Visa (TRV) may be required to visit or transit Canada.
  - Canadian officials will not allow guests to remain onboard while in a Canadian port without proper documentation.

- If you are arriving to Canada by air, you may require an Electronic Travel Authority (eTA) even if you do not require a TRV.

- Passports and other documents accepted for entry must be valid for the period of intended stay.

## Cape Verde

- Nationals of Australia, Brazil, Canada, Mexico, New Zealand, Romania and the USA:
  - Visa is required for embark/disembark.
  - Visa is not required when in transit with a cruise ship.
- Nationals of Austria, Germany, the Netherlands, Switzerland and the UK:
  - Visa is not required.
- Passports must be valid for a minimum of six months from the date of arrival.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Chile

- Nationals of Austria, Brazil, Canada, Germany, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is not required.
- Nationals of Australia and Mexico:
  - Visa is not required.
  - The Chilean government is charging a reciprocity fee to all citizens of Australia and Mexico who enter Chile through the international airport. This is not a visa.
- Passports must be valid on arrival.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Hong Kong, China

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is not required.
  - Hong Kong does not have the same requirements as Mainland China.
  - If visiting Mainland China, a Chinese visa may be required.
- Passports must be valid for a minimum of one month beyond the period of intended stay.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Sanya, China

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is required unless you qualify for the visa exemption.
  - To qualify for the visa exemption guests must be participating on a Shore excursion or tour.
- Passports must be valid for a minimum of six months beyond the date of arrival.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

### Mainland China- Shanghai embark/disembark- 144 hour visa exemption

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is required unless you qualify for the 144 hour visa exemption.
    - Guests with a traditional Chinese visa will be free to travel in China.
  - Visas must be obtained prior to sailing, are not available upon arrival and must be valid until departure from China.
  - If embarking in Shanghai and are planning to use the 144 hour visa exemption, all of the following requirements must be met:
    - Must hold a passport from one of the 53 countries whose citizens are eligible for this exemption.
    - Must arrive in China within 144 hours of the ships departure.
    - Must remain within the Yangtze River Delta Region this entire time, which means you must arrive at one of the following airports:
      - Shanghai Pudong International Airport (PVG)
      - Hangzhou Xiaoshan International Airport (HGH)
      - Nanjing Lukou International Airport (NKG)
    - Must fly directly to China from a country other than the first country visited on your cruise, even if you are not changing planes or leaving the airport.
      - If you have booked air through Holland America FlightEase and are planning to utilize the 144 hour visa exemption and your flights do not meet the requirements, please contact (800) 426 0327 to review your options.
      - If you have booked your own air you must advise your airline of your intent to travel without a visa.
  - If disembarking in Shanghai and are planning to use the 144 hour visa exemption all of the following requirements must be met:
    - Must hold a passport from one of the 53 countries whose citizens are eligible for this exemption.
    - Must depart China within 144 hours of the ships arrival.
    - Must remain within the Yangtze River Delta Region during this entire time, which means you may only fly out of the following airports:
      - Shanghai Pudong International Airport (PVG)
      - Hangzhou Xiaoshan International Airport (HGH)

- Nanjing Lukou International Airport (NKG)
      - Must fly directly from China to a country other than China or the last country visited on the cruise. This means that your flight cannot stop over in China or the port visited prior to arrival to China before reaching another country, even if you are not changing planes or leaving the airport. Transits through Hong Kong are permitted.
  - All guests must bring two photocopies of their passport photo page on letter- or A4 paper to cruise check-in. Guests should also bring two copies of their homeward travel arrangements. One will be presented at check-in, and one must be presented to Chinese immigration authorities along with your passport when disembarking the cruise.

  - More than one exemption may be applicable to your voyage.

- Passports must be valid for a minimum of six months beyond the date of arrival.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

### Mainland China- Shanghai embark/disembark- 24 hour visa exemption

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK-
  - Visa is required unless you qualify for the 24 hour visa exemption.
    - Guests with a traditional Chinese visa will be free to travel in China.
  - Visas must be obtained prior to sailing, are not available upon arrival and must be valid until departure from China.
  - If embarking in Shanghai and are planning to use the 24 hour visa exemption you must be arriving within 24 hours before the ships departure from Shanghai.
    - This option is available to all nationalities, and you must physically leave China within 24 hours of the ships departure.
    - You must remain within the Yangtze River Delta Region this entire time, which means you must arrive at one of the following airports-
      - Shanghai Pudong International Airport (PVG)
      - Hangzhou Xiaoshan International Airport (HGH)
      - Nanjing Lukou International Airport (NKG)
    - You must fly directly to China from a country other than the first country visited on your cruise, even if you are not changing planes or leaving the airport.
      - If you have booked air through Holland America FlightEase and are planning to utilize the 24 hour visa exemption and your flights do not meet the requirements, please contact (800) 426 0327 to review your options.
      - If you have booked your own air you must advise your airline of your intent to travel without a visa.
  - If disembarking in Shanghai and are planning to use the 24 hour visa exemption you must be departing China within 24 hours of the ships arrival to Shanghai.

- This option is available to all nationalities, and you must physically leave China within 24 hours of the ships arrival.
- You must remain within the Yangtze River Delta Region during this entire time, which means you may only fly out of the following airports:
  - Shanghai Pudong International Airport (PVG)
  - Hangzhou Xiaoshan International Airport (HGH)
  - Nanjing Lukou International Airport (NKG)
- You must fly directly from China to a country other than China or the last country visited on the cruise. This means that your flight cannot stop over in China or the port visited prior to arrival to China before reaching another country, even if you are not changing planes or leaving the airport. Transits through Hong Kong are permitted.
- All guests must bring two photocopies of their passport photo page on letter- or A4 paper to cruise check-in. Guests should also bring two copies of their homeward travel arrangements. One will be presented at check-in, and one must be presented to Chinese immigration authorities along with your passport when disembarking the cruise.
- More than one exemption may be applicable to your voyage.
- We are not able to offer assistance with obtaining the Chinese visa onboard the ship.
- Passports must be valid for a minimum of six months beyond the date of arrival.
- Nationals of countries not listed above should verify their requirements with their local consulates or visa service provider.

## Mainland China- Shanghai arrival and departure by cruise- 15 day visa exemption

- Nationals of Australia, Austria, Brazil, Canada, Germany, Mexico, the Netherlands, New Zealand, Romania, Switzerland, the USA and the UK:
  - Visa is required unless you qualify for the 15 day visa exemption.
  - To qualify for the 15 day visa exemption, guests must be arriving and departing Shanghai by ship, and must be booked on a tour of two or more people.
  - The tour does not have to be booked through Holland America Line but if you are booking a private tour, please verify that the travel agency being used has been approved by the Shanghai Immigration Inspection Authority to facilitate the visa-free entry process.
  - Other ports that may be visited under the 15 day visa exemption are limited to the following areas: Liaoning, Hebei, Tianjin, Shandong, Jiangsu, Zhejiang, Fujian, Guangxi, Hainan (Sanya), Dalian, Yanti, Qingdao and Beijing.

  - More than one exemption may be applicable to your voyage.

## Mainland China- Xiamen

  - Visa exemptions do not apply to Xiamen.
- Passports must be valid for a minimum of six months beyond the date of arrival.

  - All guests will undergo face-to-face screening by Indian Immigration upon arrival to India.
